

BYLAW 794/2002

A BYLAW OF THE TOWN OF NIPAWIN TO AUTHORIZE THE INCORPORATION OF A CHARITABLE CORPORATION TO MAINTAIN AND OPERATE A COMMUNITY MUSEUM IN THE TOWN OF NIPAWIN AND TO CARRY OUT ALL ACTIVITIES RELATED THERETO

WHEREAS Section 150(e) of *The Urban Municipality Act*, 1984 provides that a Council may, by bylaw:

"(e) *authorize the incorporation of a company, or providing for the acquisition of some or all of the shares of a corporation, formed for the purpose of constructing, acquiring, maintaining or operating civic auditoriums, exhibition grounds, zoos, wild animal parks, recreational or cultural facilities, including theatres, art galleries, museums or conservatories and providing for the carrying out of all related activities so long as the urban municipality has and retains controlling interest in the corporation;*" and

WHEREAS the Town of Nipawin is the owner of all those lands and premises described as NE 1/4-31-50-14-W2nd East of the Saskatchewan River and West of Road Plan CG 3877, Nipawin, Saskatchewan, upon which is situated a facility commonly known as the "Nipawin and District Living Forestry Museum" and desires to incorporate a charitable corporation for the purpose of maintaining and operating such facility, and carrying out all activities related thereto;

NOW THEREFORE the Council of the Town of Nipawin enacts as follows:

1. AUTHORIZATION TO INCORPORATE:

The Town of Nipawin is hereby authorized to incorporate a non-profit corporation pursuant to the provisions of *The Non-Profit Corporations Act* of the Province of Saskatchewan (the "Act"), to be named "Nipawin and District Forestry Museum Inc." or such other like or similar name as the Director appointed pursuant to the Act shall approve, for the purpose of maintaining and operating the Nipawin and District Living Forestry Museum and carrying out all activities related thereto.

2. CONDITIONS OF INCORPORATION:

The authorization set forth in Section 1 hereof shall be subject to the condition that the Town of Nipawin shall have and at all times retain a controlling interest in such corporation.

3. EXECUTION OF DOCUMENTS:

His Worship the Mayor, together with the Town Administrator if required, is hereby authorized to execute on behalf of the Town of Nipawin all such incorporating and other documents as may be necessary to give effect to this bylaw.

4. COMING INTO EFFECT:

This Bylaw shall come into force and take effect on the day of the final passing thereof.
