PROJECT DESCRIPTION

The project will include the construction of a surfacing structure on Highway No. 55, Highway No. 23, and Birch Road in the vicinity of Nipawin and Carrot River; for a total distance of 40.18 km.

The limits of the project are on:

- Highway No. 55 from 1.15 km west of its junction with Highway No. 123 to its junction with Highway No. 35;
- Highway No. 23 from its junction with Highway No. 55 to 9.73 km south; and
- Highway No. 3-03-42 (more commonly known as Birch Road), from its junction with Highway No. 23 to 2.68 km east.

PROJECT DETAILS

- The Contract Number for this project is H23149.
- The Contractor for this project is Potzus Paving & Road Maintenance Ltd.
- The Contractor's address as indicated on the bidder's signing block is Yorkton, SK.
- Contract supervision will be provided by Prairie Road Solutions Inc. personnel.
- The Contractor anticipates beginning aggregate production on February 5, 2024, with work expected to be completed by March 15, 2024. Roadwork is expected to commence on June 3, 2024, and is projected to be completed by October 31, 2024.
- The travelling public can expect minimal to no delays or disruptions to their normal travel schedules during aggregate production. The Contractor will provide advanced warning signs of trucks turning at gravel pits and stockpile entrances on the Highway network.
- Traffic flow through the construction area will be disrupted with traffic required to reduce speeds to 60 km/h or less. During construction, traffic may be restricted to one lane through the construction area with flag persons in attendance. The Contractor will provide the traffic accommodation.
- The estimated total cost of this project is \$21.2 million, including materials, construction engineering, and PST.
- This is a Capital Program project in the Northern Maintenance Region.
